URBANA HIGH SCHOOL PARKING RULES AND REGULATIONS

All student drivers must clearly understand that their use of a vehicle to travel to and from school is a privilege, not a right. Any student who abuses this privilege will lose the opportunity to park on school property.

Students will be assigned parking in either the Gym lot (including Cove), the Auditorium lot, or the Main (bus) lot. The Main lot will be reserved for those students on partial day schedules including, but not limited to open campus, dual enrollment, work study, internships.

During school hours, parking spaces on UHS campus are limited to UHS permitted students, FCPS staff, and legitimate visitors.

Students are NOT permitted to park in staff spaces or visitor parking AT ANY TIME. Vehicles parked illegally are subject to towing at the vehicle owner's expense.

If you are involved in any sort of accident or altercation in the parking lot, please come to the AP office immediately to report the situation.

Regulations

- 1. A current parking decal must be displayed on the rear view mirror of the registered vehicle at all times while on campus. Failure to do so may result in fines or loss of parking privileges.
- 2. Students must park in their assigned lot only.
- 3. Students are expected to arrive at school with plenty of time to report to 1st block by 7:30 am. Being tardy to school 5 times will result in the loss of parking privileges for the remainder of that term. No refund of parking fee will be made. This rule will be strictly enforced.
- 4. Students are to enter the school building as soon as they arrive at school. Hanging out in cars, and/or loitering in the parking lots is not permitted.
- 5. Parking hang tags are NOT transferable to another vehicle or another student at any time for any reason. If the student's parking situation changes (ie; student moves, student no longer drives, etc) the student must surrender the parking permit to the AP office. Students who are caught using another student's parking hang tag will lose their parking privilege for the remainder of the school year.
- 6. All vehicles must be operated in a safe and responsible manner at all times. All driving regulations must be obeyed. The speed limit on campus is **15 mph**.
- 7. The school administration reserves the right to search vehicles when on school property and seize any illegal substances or contraband such as drugs, weapons, drug paraphernalia, alcohol or similar items.
- 8. All vehicles should be locked with no valuables left inside. The school assumes no responsibility for a vehicle and its contents.
- 9. The parking lot is off limits during the school day. If a student needs to go to their vehicle for any reason, they must come to the AP office and get a pass.
- 10. Vehicles should be equipped properly to drive in all weather conditions. Permission will not be granted to leave school early because of weather conditions unless the entire school is dismissed early.
- 11. Students may not drive or ride mopeds or motorcycles on school property.
