8. Combat significant violent crime

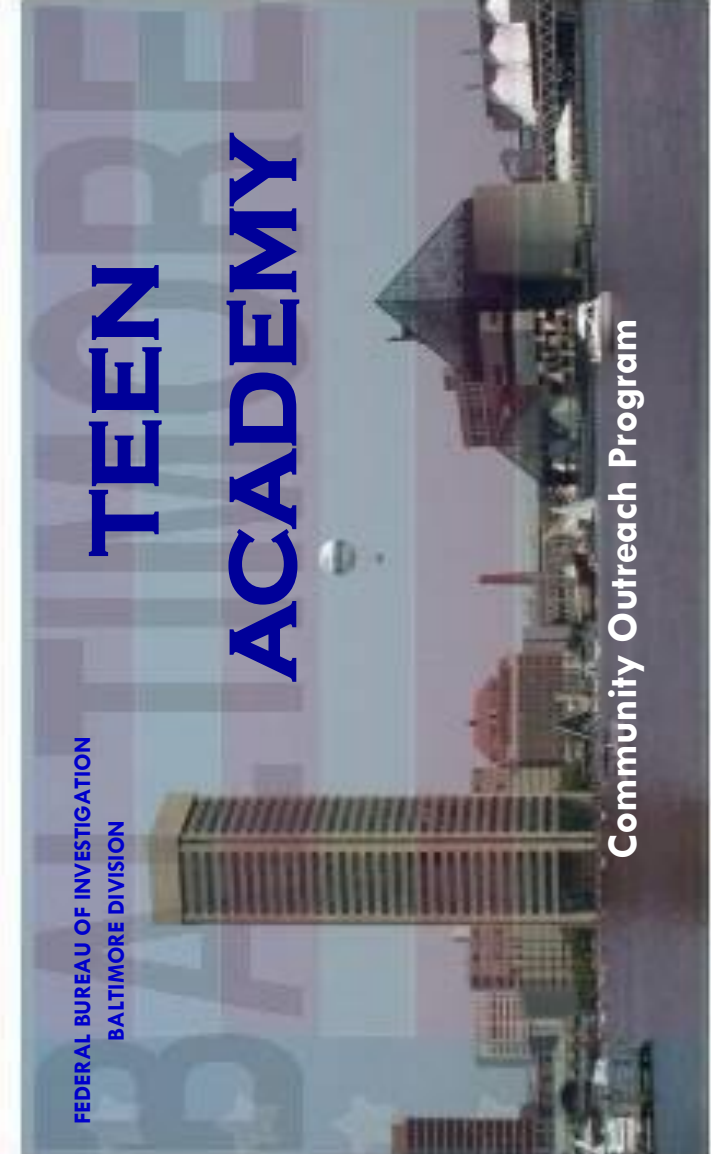

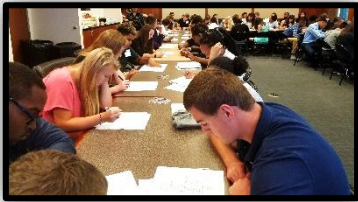

## What is a Teen Academy?

The Teen Academy is designed to promote an educational experience that we believe will provide high school students with a greater understanding of the FBI's mission. We seek to further explain to our younger generation how the FBI addresses the concerns of the community.

FBI executives and program managers will teach policies and techniques that direct their investigations. Teens will learn about major investigations and participate in a variety of "hands on" exercises that illustrate the duties and responsibilities of the FBI.



## Entrance Requirements

Candidates must meet the following criteria:

- U.S. Citizen and residence of Delaware or Maryland.
- High school students (16 to 18 years old) at the time of Teen Academy.
- GPA of 2.5 or higher.
- Obtain permission from a parent or guardian.
- Obtain reference from school principal, teacher, or guidance counselor.
- Currently enrolled in an accredited high school or home schooled in Delaware or Maryland.
- Complete an application and one page essay.
- Agree to attend the entire three day session.

## Schedule

- Registration begins at 7:45 a.m. and will conclude approximately at 4:00 p.m. on predetermined dates.

## What You Need to Know

- Students must provide their own transportation to/from the FBI Baltimore Division.
- Secure parking is available.
- No electronic devices or cameras are allowed in the FBI facilities.
- Dress Code: Professional attire.
